
The Commission re-entered Public Session at 12:11 p.m.

**ORDER TEMPORARILY SUSPENDING LICENSE  
AND SETTING HEARING**

**FINDINGS OF FACT AND CONCLUSIONS OF LAW**

This is a contested reinstatement proceeding under Ala. Code § 34-24-337. The Medical Licensure Commission of Alabama held a contested case hearing in this matter on September 25, 2024. After receiving and considering all of the relevant evidence and argument, we find that Dr. Dyken's license to practice medicine in Alabama should be reinstated and simultaneously restricted to administrative practice only, as spelled out in greater detail below.

**I. Introduction and Statement of the Case**

The respondent in this case is Jason Richard Dyken, M.D. (hereinafter "Respondent"). Respondent was first licensed by the Commission on or about August 26, 1992, having been issued license no. MD.16761. The Board's

opposition to the reinstatement of Respondent's license centers on Respondent's absence from the practice of medicine for an extended period of time.

## **II. Procedural History**

Respondent's license to practice medicine in Alabama expired on December 31, 2013. On March 4, 2024, Respondent submitted his application for reinstatement pursuant to Ala. Code § 34-24-337. On May 30, 2024, the Board, as prescribed in Ala. Code § 34-24-337(e), filed its "Notice of Intent to Contest Reinstatement." On June 27, 2024, as prescribed in Ala. Code § 34-24-337(g), the Board filed its Administrative Complaint (the "Administrative Complaint") setting forth the grounds for its opposition to reinstatement of Respondent's license.

In its one-count Administrative Complaint, the Board alleges that Respondent "been absent from the clinical practice of medicine, thereby rendering him incapable of practicing medicine with reasonable skill and safety to his patients by reason of clinical incompetency in violation of Ala. Admin. Code r. 540-X-23-.03 and Ala. Code § 34-24-360(20)a."

On September 25, 2024, we conducted an evidentiary hearing on this charge as prescribed in Ala. Admin. Code r. 545-X-3. The case opposing reinstatement was presented by the Alabama Board of Medical Examiners

through its attorneys Wilson Hunter and Alicia Harrison. Respondent was represented by attorney Russell B. Robertson. Each side was offered the opportunity to present evidence and argument in support of its respective contentions, and to cross-examine the witnesses presented by the other side. After careful review, we have made our own independent judgments regarding the weight and credibility to be afforded to the evidence, and the fair and reasonable inferences to be drawn from it. Having done so, and as prescribed in Ala. Code § 41-22-16, we enter the following Findings of Fact and Conclusions of Law.

### **III. Findings of Fact**

We find the following facts to be established by the preponderance of the admissible and probative evidence presented at the hearing.

1. Respondent graduated from The University of South Alabama College of Medicine in 1991, and completed an internal medicine residency at Carraway Hospital in Birmingham in 1994. Respondent was first licensed by the Commission on or about August 26, 1992, having been issued license no. MD.16761.

2. After residency, Respondent practiced internal medicine in the Gulf Shores area before retiring in 2001.

3. Respondent has not actively practiced medicine since 2001. Respondent kept up his license and continuing medical education for a few years, but, at the end of 2013, he chose not to. As a result, Respondent's medical license expired by operation of law on December 31, 2013. Respondent had allowed his Alabama Controlled Substances Certificate ("ACSC") to lapse on March 21, 2012.

4. Since 2001, Respondent has been working as President and Chief Executive Officer of Dyken Wealth Strategies, a financial planning consultancy based in Gulf Shores, Alabama, primarily serving physicians and dentists. Respondent also serves on the Gulf Shores City Council.

5. In 2012, Respondent was included in a random Continuing Medical Education audit. It was found that Respondent did not earn any CME during 2011. (Board Exhibit 6.) At that time, Respondent communicated to the Board that he desired to put his license in inactive retirement status. (Board Exhibits 3, 4.)

6. Respondent readily acknowledges that significant developments in medical knowledge and practice have occurred in the 20-plus years since he has actively practiced medicine, and he acknowledges that he would need significant retraining to refresh and update his competencies before re-entering clinical practice.



7. If his license is reinstated, Respondent intends to work as a principal investigator for pharmaceutical research projects. Respondent expresses his understanding that his contemplated line of work would not involve any patient treatment, and may or may not require a medical license.

8. Although at least one company has apparently expressed interest in employing Respondent as a research investigator, he does not yet have a concrete job offer.

9. During February 2024, Respondent completed 25 hours of AMA PRA Category 1 continuing medical education credits.

#### **IV. Conclusions of Law**

1. The Medical Licensure Commission of Alabama has jurisdiction over the subject matter of this cause pursuant to Act No. 1981-218, Ala. Code §§ 34-24-310, *et seq.* Under certain conditions, the Commission “shall have the power and duty to suspend, revoke, or restrict any license to practice medicine or osteopathy in the State of Alabama or place on probation or fine any licensee.” Ala. Code § 34-24-360.

2. The Commission also has power to order reinstatement, or, in appropriate circumstances, to deny reinstatement, of licenses to practice medicine in Alabama. In a contested reinstatement proceeding such as this one, the

Commission has discretion to reinstate, deny reinstatement, or to reinstate a license and simultaneously impose conditions on the license:

**The commission may deny reinstatement of a license upon a finding that the applicant has committed any of the acts or offenses set forth in Sections 34-24-360, 34-24-57, 16-47-128, or any other provision of law establishing grounds for the revocation, suspension, or discipline of a license to practice medicine. In addition, the commission may reinstate the license and impose any penalty, restriction, or condition of probation provided for in subsection (h) of Section 34-24-361 and Section 34-24-381 as the commission deems necessary to protect the public health and the patients of the applicant. If, at the conclusion of the hearing, the commission determines that no violation has occurred, the license of the applicant shall be reinstated.**

Ala. Code § 34-24-337(h) (emphasis added).

3. Respondent was properly notified of the time, date and place of the administrative hearing and of the charges against him in compliance with Ala. Code §§ 34-24-361(e) and 41-22-12(b)(1), and Ala. Admin. Code r. 545-X-3-.03(3), (4). At all relevant times, Respondent was and is subject to the Commission's jurisdiction.

4. A physician's license to practice medicine in Alabama may be revoked, restricted, or otherwise disciplined if it is shown, after notice and hearing, that the physician is "unable to practice medicine or osteopathy with reasonable skill and safety to patients by reason of a demonstrated lack of basic medical knowledge or clinical competency." Ala. Code § 34-24-360(20)a.

Moreover, under the Board's reentry-to-practice rule, "[a] physician's absence from clinical practice for more than two years creates a rebuttable presumption of clinical incompetence." Ala. Admin. Code r. 540-X-23-.03(1).

5. Respondent admits that the rebuttable presumption of clinical incompetency provided for in Ala. Admin. Code r. 540-X-23-.03(1) applies to him under the facts of this case. Respondent, however, has advanced no substantial effort to rebut that presumption. Instead, Respondent seeks reinstatement of his license to perform work that does not involve direct patient contact or treatment decisions. We therefore conclude as a matter of law that Respondent, at this time, remains clinically incompetent to practice medicine in the State of Alabama.

#### **V. Decision**

Based on all of the foregoing, it is **ORDERED, ADJUDGED, AND DECREED** as follows:

1. That the Respondent, Jason Richard Dyken, M.D., is adjudged clinically incompetent to practice medicine at this time under Ala. Code § 34-24-360(2) and Ala. Admin. Code r. 540-X-23-.03(1), as charged in Count One of the Administrative Complaint.

2. That Respondent's license to practice medicine in the State of Alabama is hereby **REINSTATED** and is simultaneously **RESTRICTED** as follows:

- a. Respondent's practice is restricted to administrative medicine only. Respondent shall have no clinical responsibilities, shall have no patient contact, and shall not be involved in diagnostic or treatment decisions.
- b. Respondent shall not perform work or services requiring a license to practice medicine in the State of Alabama except pursuant to a written practice plan that has been approved in advance by the Commission. A practice plan will contain, at a minimum, specific information such as: the proposed name of the employer; the proposed scope of services to be provided; the proposed days/hours of work; and other details deemed pertinent by the Commission.

3. That no administrative fines, nor administrative costs of these proceedings, are assessed against Respondent at this time.
